\*\*\*The property is currently listed at \$1.75 million; however, the seller has asked us to publicly state that "they are extremely motivated to sell, and any-and-all bids will be considered regardless of the bid amounts".\*\*\*

Property *5562-A* includes 1.131 acres, a church and cemetery. The church is currently occupied and is on a month-to-month lease. Rent is \$2,500 per month and the seller states the rent is usually paid early or in advance. The cemetery does have plots still available. Should the new owner elect to terminate the rental arrangement they will be required to give the church 120 days advance notice. **Do not disturb the tenant.** 

Property **5562-B** includes 0.877 acres and is located on a prime corner of McFarland Parkway and Union Hill Road. The property appears to us to have access via an ingress and egress easement as is shown in the *Survey* and *Deed with Easement Information* both of which are available for viewing in the download section above. It is advised that the purchaser perform their own due diligence and seek their own advice from legal counsel prior to bidding.

Property **5562-C** is the total property which includes both properties **5562-A** & B and totals 2.008 acres.
