# NOTICE OF PERMIT ISSUANCE

Enclosed is Permit Number 0423613-001-DWC/CL to construct a domestic wastewater collection/transmission system, issued pursuant to 403.087(1), Florida Statutes.

## NOTICE OF RIGHTS

This action is final and effective on the date filed with the Clerk of the Department unless a petition for an administrative hearing is timely filed under Sections 120.569 and 120.57, F.S., before the deadline for filing a petition. On the filing of a timely and sufficient petition, this action will not be final and effective until further order of the Department. Because the administrative hearing process is designed to formulate final agency action, the hearing process may result in a modification of the agency action or even denial of the application.

### Petition for Administrative Hearing

A person whose substantial interests are affected by the Department's action may petition for an administrative proceeding (hearing) under Sections 120.569 and 120.57, F.S. Pursuant to Rules 28-106.201 and 28-106.301, F.A.C., a petition for an administrative hearing must contain the following information:

- (a) The name and address of each agency affected and each agency's file or identification number, if known;

- (d) A statement of all disputed issues of material fact. If there are none, the petition must so indicate;
- (e) A concise statement of the ultimate facts alleged, including the specific facts that the petitioner contends warrant reversal or modification of the agency's proposed action;
- (f) A statement of the specific rules or statutes that the petitioner contends require reversal or modification of the agency's proposed action, including an explanation of how the alleged facts relate to the specific rules or statutes; and
- (g) A statement of the relief sought by the petitioner, stating precisely the action that the petitioner wishes the agency to take with respect to the agency's proposed action. The petition must be filed (received by the Clerk) in the Office of General Counsel of the Department at 3900 Commonwealth Boulevard, Mail Station 35, Tallahassee, Florida 32399-3000, or via electronic correspondence at <a href="Magency\_Clerk@dep.state.fl.us">Agency\_Clerk@dep.state.fl.us</a>. Also, a copy of the petition shall be mailed to the applicant at the address indicated above at the time of filing.

# Time Period for Filing a Petition

In accordance with Rule 62-110.106(3), F.A.C., petitions for an administrative hearing by the applicant and persons entitled to written notice under Section 120.60(3), F.S., must be filed within 14 days of receipt of this written notice. Petitions filed by any persons other than the applicant, and other than those entitled to written notice under Section 120.60(3), F.S., must be filed within 14 days of publication of the notice or within 14 days of receipt of the written notice, whichever occurs first. You cannot justifiably rely on the finality of this decision unless notice of this decision and the right of substantially affected persons to challenge this decision has been duly published or otherwise provided to all persons substantially affected by the decision. While you are not required to publish notice of this action, you may elect to do so pursuant Rule 62-110.106(10)(a), F.A.C.

The failure to file a petition within the appropriate time period shall constitute a waiver of that person's right to request an administrative determination (hearing) under Sections 120.569 and 120.57, F.S., or to intervene in this proceeding and participate as a party to it. Any subsequent intervention (in a proceeding initiated by another party) will be only at the discretion of the presiding officer upon the filing of a motion in compliance with Rule 28-106.205, F.A.C. If you do not publish notice of this action, this waiver may not apply to persons who have not received a clear point-of-entry.

This permit is issued under the provisions of Chapter 403, Florida Statutes (F.S.), and Chapters 62-4 and 62-604, Florida Administrative Code (F.A.C.).

The above-named permittee is hereby authorized to construct the facilities shown on the application and drawings and other documents on file with the Department and made a part hereof and specifically described as follows:

# DESCRIPTION OF PROJECT:

This project involves a low-pressure sewer (LPS) domestic wastewater collection/transmission system that is constructing approximately 421 linear feet of 2-inch HDPE force main, two grinder pump stations, and 55 linear feet of 2-inch PVC force main to provide service for two single family homes.

The project will connect the proposed 2-inch force main to a proposed 2-inch force main at First Avenue per the 20722 First Ave Grinder Low Pressure Sewer DEP Permit No. 0412840-001-DWC/CL, which has not been cleared for operation. The wastewater from the project will eventually flow to Panama City Beach WWTP No. 1, FL0021512, for treatment.

The construction of the wastewater collection/transmission project shall be in accordance with the Application Construction Plans certified on July 13, 2022, by Brittany Trumbull, P.E., for the design of the wastewater system portion of the project.

**LOCATION OF PROJECT:** The project site is located along Chelsea Drive between West End Drive and First Avenue in Panama City Beach, Bay County, FL.

Upon completion of construction of the collection/transmission system project, and before placing the facilities into operation for any purpose other than testing for leaks or testing equipment operation, the permittee shall submit to the Department's District Office Form 62-604.300(8)(b), Notification of Completion of Construction for a Domestic Wastewater Collection/Transmission System. - 3. The new or modified collection/transmission facilities shall not be placed into service until the Department clears the project for use. [62-604.700(3)]
- 4. Permit revisions shall only be made in accordance with Rule 62-4.050(4)(s), F.A.C. Request for revisions shall be made to the Department in writing and shall include the appropriate fee. Revisions not covered under Rule 62-4.050(4)(s), F.A.C., shall require a new permit. [62-604.600(8)]
- 5. Abnormal events shall be reported to the Department's Northwest District Office in accordance with Rule 62-604.550, F.A.C. - 7. This permit is for CONSTRUCTION ONLY of the collection/transmission system project. This permit does not authorize the connection of this collection/transmission system project to the designated receiving collection/transmission system until the receiving system has been constructed and cleared for use by the Department. The receiving collection/transmission system's proposed 2-inch force main at First Avenue per the 20722 First Ave Grinder Low Pressure Sewer DEP Permit No. 0412840-001-DWC/CL, has not been cleared for operation. This permit shall not be constructed to infer that the clearance necessary for connection shall be granted. Any such clearance shall be granted only when reasonable assurance is given that adequate treatment and disposal is available in accordance with Department rules, regulations, and permits. Partial clearance may be granted, if required. [62-604.130(1) and 62-604.600(7)]
