#### Buddy,

Attached is an illustration of the dockable space for 107 Armory Court. The dockable space is determined by extending the side property lines, and every portion of the dock should stay at least 15' from the side property lines, UNLESS the neighbor signs off for the dock to be closer than 15' to the lines.

In the attachment, the dockable space is within the red triangle. Possibly a boardwalk style dock may possibly be permitted. Also, we will need an HOA approval letter prior to the issuance of a permit for any type of encroachment.
